We will encourage teams to be formed from families and friends of the HYF players. The participants cannot form their own teams; the teams will be prepared by a random pick by the Powder Puff board members.

In case of an accident while participating in the HYF Season Opener Powder Puff Fundraiser Game, all participants are covered by their own insurance policy. All participants should be in good physical condition and accept their own risks in participating in HYF Season Opener Powder Puff Fundraiser Game. HYF Season Opener Powder Puff Fundraiser is not responsible for accidents that occur before, during, or after game play, unless the injury is a result of employee negligence. In order to play, the participants must sign and date the "RISKS AND HAZARDS STATEMENT OF UNDERSTANDING AND RELEASE" (next page).

Individual Sportsmanship:

The following criteria have been established to promote appropriate conduct and to provide clear expectations for all participants and spectators. Individuals (participants, coaches and spectators) will be held responsible for their actions.

Guidelines for Sportsmanship

- The team should not need to be warned about unnecessary roughness. *None* will be tolerated.
- If any player is ejected by an official and the team CONTINUES to display unsportsmanlike conduct. The team will be forced to forfeit the game.
- Players other than the captain persist in questioning the officials or any player repeatedly argues with an official. That participant will be removed from the game.
- Spectators clearly related to the team continue to fail to conduct themselves in an orderly fashion, will be asked to leave the schools property.
- Spectators clearly related to the team engage in disorderly conduct which jeopardizes the officials' control of the game, will be asked to leave the schools property.
- The team displays general roughness which jeopardizes the safety of the participants. This includes action by any player with the intent of physically harming another player or official.

RISKS AND HAZARDS STATEMENT OF UNDERSTANDING AND RELEASE

The undersigned hereby acknowledges and agrees to the following statements:

1. I, (herein "participant") expect and intend to participate in the HYF Season Opener Powder Puff Fundraiser games and activities to be sponsored by HYF during 2010 season, following the execution of this Statement of Understanding and Release. I also agree to have the required insurance coverage before participating in any activities.
2. In consideration of the HYF's sponsorship and direction of the activity, and his/her participation, participant hereby states that he/she has read and fully understands the Risks and Hazards Statement which is included herein and releases and discharges the Huntley Youth Football, the Marlowe Middle School, and their officers, agents and employees and volunteers from any and all claims, damages, losses or injuries connected therewith, including, but not limited to, any loss, damage or injury suffered by participant or others, as a result of failure to obey safety regulations or resulting from the exercise of the activity coordinator or other individuals acting in good faith response to emergencies and exigencies on this activity whether at the Marlowe Middle School or any other location.
3. Participant further agrees and understands that during the activity, he/she will be under the direction of the instructor or director approved by HYF and specifically agrees to comply with all reasonable directions and instructions by the instructor or director during the course thereof.
4. Participant understands and acknowledges that there are specific risks of injury to person and/or property that are associated with activity, including risks related to travel hazards, terrain, weather, and other circumstances. Participant also acknowledges that he/she understands that the activity could have but is not limited to the following risks: **Participants acknowledge that all HYF Sports may include dangerous games, injuries can range from minor scrapes and bruises to broken bones, head injuries, paralysis, and even death.** Participant specifically assumes the risks associated with such conditions.
5. **Participant understands and acknowledges that Huntley Youth Football, Marlowe Middle School, and the HYF Season Opener Powder Puff Fundraiser assumes no liability for personal injuries or property damages to participants or to third parties arising out of activity, except to the extent that such liability is imposed by law. Participant agrees to indemnify and to save harmless, the HYF, Marlowe Middle School, HYF Powder Puff Fundraiser and its officers, agents, employees, and volunteers from any claim or liability arising out of the acts or omissions of the participant during any such activity, subject to any limitations or restrictions against such indemnification that are imposed by law.**
6. Participant understands and acknowledges that there may be unsupervised times before, during, or after the hours of the sponsored activity. It is understood that during this time participants will conduct themselves as responsible individuals as well as adhere to all applicable laws and statutes in effect. Failure to comply with this section may result in physical harm or property loss due to hazards beyond the HYF and Marlowe Middle School's control. Failure to comply may also result in expulsion from the activity. The HYF and Marlowe Middle School will not be responsible for any such acts nor any costs resulting from expulsion from the activity.
7. **The participant hereby understands that he/she should arrange for appropriate personal health insurance coverage (e.g., hospital/medical insurance, health insurance, etc.) during the period of the activity. The participant agrees and understands that he/she will be personally responsible for any medical costs incurred during this activity.**
8. I agree *not* to use any illegal drugs or alcohol while undertaking this activity with The HYF Season Opener Powder Puff Fundraiser.

If the participant(s) are either kicked out of league play, or decide to withdraw from league play for any reason, they will forfeit any deposits or monies that have been paid in order to play in the league. **ONLY PARTICIPANTS IN THE GAME WILL RECEIVE A GAME JERSERY. THE \$40.00 REGISTRATION FEE WILL NOT BE REFUNDED FOR ANY REASON. IF YOU WITHDRAW FROM YOUR TEAM FOR ANY REASON AT ANY TIME, YOU UNDERSTAND THAT YOUR REGISTRATION FEE WILL BE CONSIDERED A DONATION TO HYF.** There is a limited amount of space and the deposit guarantees a spot on one of the HYF Powder Puff teams.
